The Community Council has no power to intervene, it is a private matter, and the way forward is to go and get legal advice. It was suggested that it may be worth contacting the Police Commissioner to ask for a missing person if the owner of the land cannot be found.</i></p> <p>ch. <b>Casglu Sbwriel / Litter Picking</b>  Angen gwneud asesiad risg. Cllr Geraint Davies to ask if church bells could be rung.</i></p> <p>dd. <b>Cyflymder Drefach Speed Limit</b>  Derbyniwyd diweddariad yn dweud / An update was received:  <i>"It would seem highly likely that, as a school location, it will qualify for a 20mph speed limit in 2023, when the change to national speeds limits is introduced by the Welsh Government. Data from the Vehicle Activated Sign installed on the western side of Drefach inside the present 30mph limit suggests that the average speed of traffic during the day time is close to the 30mph limit, though the average speed is a little higher at night time. At present it would seem there is no real formal justification available for considering additional measures relating to traffic calming at this location at present, in advance of the likely change to the speed limit in 2023."</i></p>
