b.	Cae Chwarae Cae Sarn Playing Field – Mae pwyllgor y Cae Chwarae wedi cael arwydd wedi ei wneud ar gyfer amgylchiadau Covid-19 ac wedi gwneud asesiad risg. Maent hefyd am blanu coed a blodau gwyllt mewn darn gwlyb o'r parc, mae'r Clerc yn aros am ymateb wrth y Cyngor Sir er mwyn cael caniatad i wneud hyn. They are also planting trees and wild flowers in a wet area of the park, the Clerk is waiting on a response from the County Council to enable them to do this. a.	Penderfynwyd cynnal y cyfarfod nesaf ar nos Fawrth, 3ydd o Dachwedd am 7.30yh dros gyfrwng Zoom. <i>It was decided to hold the next meeting and the AGM on the 3rd November at 7.30pm via Zoom.</i>
b.	Yr Hen Ysgol, Cwrtnewydd. Problem wedi codi gyda cwrs yr afon yn torri mewn i'r wal gefn ac yn mynd i achosi'r wal i gwympo. Angen i'r Clerc ddweud wrth yr adran briffyrdd amdano. <i>A problem has arisen with the course of the river where the river has been cutting into the gabion wall and it is on the verge of collapsing. Clerk needs to report to the land drainage department.</i>
c.	Arwydd Cwrtnewydd wedi ei ddwyn eto. <i>Cwrtnewydd sign has been stolen again.</i>
ch.	Codwyd bod cyflymder traffig yn Nrefach yn uchel, yn enwedig yn mynd trwy ganol y pentref. Mae'r heddlu dal yn mynd yno ac wedi bod yna'n ddiweddar. Gofynnwyd i'r Clerc ofyn i'r Cyngor Sir ail ystyried roi 'speed bumps' ar yr hewl ac efallai tynnu'r cyfymder lawr i 20mya. <i>It was raised that the speed of traffic through Drefach was fast, in particular through the middle of the village. The policy still patrol the area with a speed gun. However it was asked whether the Clerk can ask the County Council to re consider putting speed bumps on the road and maybe reduce the speed to 20mph.</i>
