| 3. | <u>Materion yn Codi – Matters Arising</u> |
| a. | Cae Chwarae Cae Sarn Playing Field – Cafwyd crynodeb o'r hyn a drafodwyd yn y cyfarfod ar yr 21ain o Ionawr yn Ysgol Cwrtnewydd. Mae'r Cyngor Sir wedi cytuno i dalu am y gwaith atgyweirio sydd angen ei wneud ai wneud cyn diwedd mis Mawrth. Roeddent hefyd wedi cysylltu gyda ROSPA i gael archwiliwr i'r safle i gwrdd a'r Cyngor Cymuned. Roedd pawb yn hapus i'r Cyng Geraint Hatcher a'r Cyng Geraint Davies i gwrdd a'r archwilydd. Byddai yswiriant y Cyngor Cymuned yn cynnwys 'Public Liability' am y cae chwarae ond dim am unrhyw niwed i'r lle chwarae. Y bwriad fyddai i dderbyn y lease wrth y Cyngor Sir a treialu'r defnydd o'r cae chwarae am gyfnod o 3 mlynedd. Mi fyddai'n rhaid i'r pentrefwyr gadw a chynnal y cae chwarae, dim ond talu am yr yswiriant a'r archwiliad blynyddol y byddai'r Cyngor Cymuned yn ei wneud. Mi fydd y cyfarfod nesaf ar yr 11eg o Chwefror yn Ysgol Cwrtnewydd am 7.30yh lle byddwn yn cael adborth pellach o'r pentrefwyr yn dilyn holiadur y maent wedi ei ddanfod ogwmpas y pentref. A summary was received of what was discussed in the meeting on the 21 st January at Cwrtnewydd School. The County Council have agreed to pay for the repair works that are needed now and to carry them out before the end of March. They had also contacted ROSPA to have an inspector out on site to meet the Community Councillors. Everybody was happy for Cllr Geraint Hatcher and Cllr Geraint Davies to meet the inspector on site. The Community Council's Public Liability insurance would cover the playing field but not cover any damage to property. The aim is to lease the playing field from the Community Council and trial the use of the play area for a period of 3 years. The residents would have to maintain the playarea, the Community Council would only insure and inspect the play area once a year. The next meeting will be held on the 11 th February at Cwrtnewydd School 7.30pm where the response of the residents to a questionnaire circulated will be discussed. |

Penderfynwyd dim ond bod 'Public Liability' gyda'r Cyngor y dylsai hyn fod yn ddigon. Gofynwyd i'r Clerc ofyn i Gyngorau Cymuned eraill i weld beth mae nhw'n ei wneud ac hefyd darganfod gwerth y |

| | <p>gofgolofn. Roedd y Clerc wedi cael tystysgrif pob cyn-yymddiriedolwr ond un ac roedd y deeds yn barod i'w arwyddo. Bydd hyn yn cael ei wneud yng nghyfarfod mis Mawrth. Gofynnodd y Cyng Helen Howells i'r Clerc ddarganfod beth yn union mae'r ymddiriedolwyr yn gyfrifol amdau. The Clerk had been quoted a price to insure the war memorial and this was around £1000.00 per year. It was decided that the Council only needs the Public Liability and this should be enough. The Clerk was asked to contact other Community Councils to see what they do and to also get a value of what the Memorial is worth. The Clerk had gained the death certificates for all but one of the former trustees and the new deed of trust is now ready to be signed and this will be done in March's meeting. Cllr Helen Howells asked the Clerk to discover what exactly the Councillors are liable for as trustees of the war memorial.</p> |
