Roedd pawb yn hapus gyda'r dogfennau ac felly mi fyddent yn cael eu arwyddo cyn diwedd yr wythnos. Mi fydd Sul y Cofio yn digwydd ddydd Sul yr un fath ag arfer, cynigwyd bod pob perchenog torch pabi yn mynd a hi yn ôl gyda nhw i'w addoldai ac y byddai un y Cyngor Cymuned yn mynd i Eglwys y Plwyf gan fod y gwaith o symud y gofgolofn yn dechrau yr wythnos nesaf.
