1.	<u>Datgelu Buddianau Personol/Declare Personal Interests</u> Gwnaeth y Cyng Eluned Jones ddatgan diddordeb ym mhwynt 3a. <i>Cllr Eluned Jones declared a personal interest in point 3a.</i>
2.	<u>Cadarnhau'r Cofnodion / Agree Minutes</u> Cafwyd cofnodion cyfarfod mis Medi yn gywir gan y Cyng. Emyr Rees ac fe'i eiliwyd gan y Cyng Bill Green. <i>The September minutes were proposed as a true record by Cllr Emyr Rees and seconded by Cllr Bill Green.</i>
3.	<u>Materion yn Codi – Matters Arising</u>
a.	Cae Chwarae Cae Sarn Playing Field – Daeth ymateb wrth Paul Arnold o'r Cyngor Sir yn cynnig naill ai rhoi tsiaen newydd i'r siglenni neu ail wneud y concriid o dan y sedd. Penderfynodd pwyllgor y cae chwarae cael y tsiaen newydd. Codwyd y pwynt bod angen i'r Cyngor Cymuned fynd i archwilio'r safle, cynigwyd enw'r Cyng Emyr Rees i fynd allan i archwilio'r safle gyda'r Cyng Eluned Jones. Roedd yr archwiliad hefyd yn codi pwynt am y ffens oamgylch y safle, nid yw'n glir eiddo pwy yw'r ffens, mi fydd y Clerc yn cysylltu gyda perchnogion y cae Miss Petty. <i>A response was received from Paul Arnold from the County Council they are willing to either replace the swing chains or the concrete base under the bench, the park committee have opted for the swing chains. The point was raised that the Community Council need to inspect the site, Cllr Emyr Rees' name was proposed to visit and inspect the site with Cllr Eluned Jones. The inspection report also raised the matter of the parameter fence, it is not clear who owns this fence, the Clerk will contact the field owner Miss Petty.</i>
b.	Ymgynghoriad Cau Ysgolion – Consultation on School Closures – Nid oes ymateb ffurfiol wedi dod oddi wrth y Cyngor Sir ond dywedodd y Cyng Euros Davies bod adroddiad yn cael ei ysgrifennu ar hyn o bryd i'w roi gerbron y Cabinet a'r bwriad yw i roi ysgolion Cwrtnewydd a Llanwnnen ar y farchnad

	<p>agored. <i>A formal response has not been received from the County Council however Cllr Euros Davies said that a report is currently being prepared to be presented to the Cabinet and the proposal is to put Cwrtnewydd and Llanwnnen Schools on the open market.</i></p>
c.	<p>Cyflymder Gorsgoch Speed Limit: Nid oedd ymateb wedi ei dderbyn eto oddi wrth y Cyngor Sir ond ychwanegodd y Cyng Alwena Williams bod bws ysgol Dyffryn Cledlyn yn pigo plant fynu a'i gollwng tu allan i'r Neuadd bob dydd nawr. <i>No formal response had been received from the County Council to date but Cllr Alwena Williams did add that the Dyffryn Cledlyn School bus now picks up and drops off children outside the hall.</i></p>
ch.	<p>Hyfforddiant Defibrilliwr Defibrillator Training – Cynhaliwyd yr hyfforddiant ar nos Wener y 29ain o Fedi a mynychodd 17 o bobl. Codwyd bod angen monitro'r peiriannau bob mis, newid y batri bob ryw 5 mlynedd a newid y 'pads' unwaith bod y dyddiad sydd ar y pecyn wedi pasio, mae cost ynghlwm wrth hyn i gyd. Gofynwyd i'r Clerc gysylltu gyda Sioe Cwmsychpant er mwyn gwneud yn siwr eu bod yn ymwybodol o hyn ac i wirio os mae nhw sydd yng nghofal y costau yma. Fe wnaeth person a ddaeth l'r hyfforddiant siarad gyda'r Clerc yn cynnig bod person yn cael ei benodi ymhob ardal i fod ar gael l'w ffonio petae person yn cael trawiad ar y galon. Fe wrthododd y Cynghorwyr Cymuned y syniad gan eu bod o'r farn y byddai hyn yn rhoi gormod o gyfrifoldeb ar un person, ond y byddai'n syniad rhoi poster yn Neuadd Drefach ac yn y Capeli yn dweud lle mae'r Defibrilliwr agosaf. <i>The training was held on Friday the 29th September and 17 people attended. It was raised that there is a requirement to monitor the machines monthly, change the battery ever 5 years and change the pads once the expiry date has passed, there is a cost involved with all of this. The Clerk was asked to contact Cwmsychpant Show in order to ensure that they are aware of this and to check that they will be in charge of covering the costs. The Clerk had also been approached by a member of the Community following the training, with an idea that a designated person could be allocated for each area so if someone was to have a heart attack that they could be called to come and assist. The idea was rejected by the Community Councillors as it was felt that this would provide too much responsibility on one person, but putting a poster in Drefach Hall and the Chapels stating where the nearest Defibrillator is would be a good idea.</i></p>

dd.	<p>gyflwyniad arbennig a gofyn iddo a fyddai'n fodlon gwneud cyflwyniad tebyg unwaith eto ar ddechrau'r flwyddyn gan fod nifer o bobl wedi methu a mynychu'r digwyddiad. <i>On the 30th September two presentations were given one on Desin in Cwmsychpant and another by Simon Evans from Cwrtnewydd regarding the history of the Parish dating back to the Stone Age. It was decided to write to Simon Evans congratulating him on a brilliant presentation and asking him whether he would be willing to do a similar presentation again at the beginning of the year as many people were unable to attend.</i></p> <p>Cyflymder Drefach Speed Limit – Derbyniwyd dau lythyr drwy law Mr Griffiths ynglyn ai lythyr gwreiddiol, un wrth yr Heddlu a'r llall wrth y Cyngor Sir, dywedwyd bod y cyflymder yn cael ei fonitro ond ei fod yn anhebygol o gael ei newid yn y dyfodol agos. <i>Two letters of response to Mr Griffiths' letter had been received from Mr Griffiths' himself, one from the police and another from the County Council stating that the speed limit in the village is now being monitored but unlikely to change.</i></p>
