1.	<b><u>Datgelu Buddianau Personol/Declare Personal Interests</u></b> Dim / None
2.	<b><u>Cadarnhau'r Cofnodion / Agree Minutes</u></b> Cadarnhawyd cofnodion mis Rhagfyr yn gywir gan y Cyng Geraint Davies ac eiliwyd gan y Cyng Hazel Thomas. <i>The December minutes were agreed as a true record by Cllr Geraint Davies and seconded by Cllr Hazel Thomas.</i>
3.	<b><u>Materion yn Codi / Matters Arising</u></b>
a.	Lwfans y Clerc / Clerks Allowance – Does dim rhaid i'r Cyngor Cymuned dalu am costau swyddfa'r Clerc, ac fe allai hawlio hyn nol trwy HMRC. Cytunwyd i beidio a talu'r lwfans yma ac roedd y Clerc yn hapus gyda hynny. <i>The Communtiy Council don't have to pay office fee to the Clerk, and she can claim this back from HMRC in any case. It was agreed to not pay this allownace and the Clerk was happy with this.</i>
b.	Cwrtnewydd Rainbow Therapy Goats – Roedd arwydd wedi cael ei roi fynu yn gofyn am rwbwl er mwyn rhoi ar y ddaear, does dim wedi digwydd yno hyd yma felly nid oes angen i'r Clerc gysylltu gyda'r Cyngor Sir. Penderfynwyd monitro'r sefyllfa. <i>A sign had been put up asking for rubble to be put on the land, nothing has happened there to date and therefore the Clerk does not need to contact the County Council. It was decided to monitor the situation.</i>
c.	Afon Cledlyn Cwrtnewydd River Cledlyn – Daeth CNC nol i ddweud mae nid nhw sydd yng ngofal yr afon na'r stepiau a'r railings, ac mae'r riparian owner sydd yn gyfrifol. Gan mae hewl y cyngor sydd gyferbyn mae'n debyg mae efallai mae'r Cyngor Sir sydd a gofalaeth drosto, Y Clerc i ddanfôn ehost i ofyn iddynt atgyweirio'r stepiau a'r railings. <i>NRW responded to say that they are not responsible for the river or the steps and railings and that it's the responsibility of the riparian owner. The Council road runs adjacent and therefore it is likely that they are responsible. The Clerk to send an email asking for them to repair the steps and railings.</i>
