ch.	<p><i>Cllr Brian Thomas a question on what is happening with the plan to prevent flooding in Llanybydder and here is the answer: "We have been discussing this matter for a while with Natural Resources Wales (NRW) and Dŵr Cymru. We are of the opinion that excavation is necessary but NRW has said that this will not be possible because it goes against their policies. Welsh Water has said that there is no natural channel for the water to flow, but we can see that there is a historical and natural channel. We have not asked them to reopen this channel. These conversations were held over a year ago and we haven't heard anything since." Need to respond to this in order to squeeze them because a lot of money has already been spent.</i></p>

We can also confirm that both the above roads have been referred for surfacing and have been included on our forward programme of works and has been prioritised accordingly along with other schemes of a similar nature across the county.</i></p> <p><i>Unfortunately, the budget for all highway maintenance and improvements is very limited and as such we are unable to give you a time scale as to the possible programming of any improvements. However, please be assured that we will do our utmost to try and accommodate your request at the earliest opportunity.</i></p>
